Pursuant to Article V, Section 14 of the Condominium by-laws, I hereby request permission to make the alteration, modification, improvement and/or repair more fully described on the attached document (hereafter referred to as "the Work") in the above Unit. I hereby represent that the Work contemplated does not involve a Major Work as such term is used and defined in the Rules and Regulations of 260 West Broadway Condominium and the Alteration, Modification, Improvement and Repair Policies and Procedures of the 260 West Broadway Condominium.

1. In the event I employ contractors, before any portion of the Work is begun, I hereby agree:

(i) To provide you with copies of every agreement made with contractors, subcontractors and suppliers, including drawing or scope of Work.

These Certificates shall be delivered to the Managing Agent before any portion of the Work is commenced.

2. It is understood that I assume all risks of damage to the Building, its common areas, and to the persons and property in the Building, which may result from the Work being performed.

3. I hereby indemnify you, the managing agent and other tenants and unit owners of the Building for any damages suffered to personal property as a result of the Work performed whether or not caused by negligence, and to reimburse you and your managing agent for any expense, including attorneys' fees and disbursements, incurred as a result of the Work.

4. All Work performed shall be in accordance with the Alteration, Modification, Improvement and Repair Policies and Procedures of 260 West Broadway Condominium as to hours of Work, noise, discarding of refuse, use of elevators, and all other rules regarding the Work.

5. I recognize that by granting consent to the Work, you do not profess to express any opinion as to the feasibility of the Work, nor to the fact that the Work does not constitute Major Work which would require more extensive review and approval.

6. I agree that a \$1,000 refundable deposit is required before the Work can begin, which may be applied by you against any liability I have to you arising out of or in connection with the Work. I acknowledge that inspection of the completed Work by Management will be required before any unapplied portion of this deposit is refunded.

7. This agreement may not be changed orally.
